# Executive Director's Report - Presented by Lauri Stewart - Video time stamp 0:20:24

Lauri Stewart provided a brief background report of the Executive Director's activities since coming onboard in September.

- September *Review of where we are and how we got there.* This included onboarding, orientation, and review of materials to catch up on the history of the Commission.
- October Where do we need to be? This included evaluating administrative and operational processes; our compliance with requirements; and studying similar boards, commissions and volunteer operations.
  - November Bridging the gap between where we are and where we need to be.
  - Drafting bylaws for the Commission to review.

### Future priorities include:

- Approval of the bylaws
- Review of the rules every two years as required by statute.
- Continue to develop and expand the rules.
- Develop processes and tracking for implementation and compliance of the standards.
- Expand outreach and educational efforts.
- Improve processes for gathering input from impacted constituencies.
